TERMS AND CONDITIONS – MALDIVIAN GIVEAWAY

Promotion Overview

1. **"Maldivian Giveaway"** (hereinafter referred to as the **"Promotion"**) is a promotion conducted by Ooredoo Maldives PLC (hereinafter referred to as **"Ooredoo"**) in which Customers of Ooredoo stand a chance to win return tickets to Dhaka, Bangladesh via Maldivian Airlines. The winners of the Promotion will be selected via lucky draw conducted among the Eligible Customers as specified herein.

Promotional Period

2. The Promotion shall commence from 00:00 Hours on 1st August 2026 and shall continue in 2 (two) phases as follows:
 - (a) Promotional Period 1: from 00:00 hours on 1 August 2026 until 23:59 hours on 31 August 2026; and
 - (b) Promotional Period 2: from 00:00 hours on 1 September 2026 until 23:59 hours on 31 August 2027.
3. During the Promotional Period 1, 3 (three) lucky draws will be taken among Eligible Customers of the relevant Eligible Period on the dates specified in Clause 5.
4. During the Promotional Period 2, 4 (four) lucky draws will be taken among Eligible Customers of the relevant Eligible Period on the dates specified in Clause 5.
5. The Lucky Draw Dates and their relevant Eligible Periods are as follows:

Eligibility

6. Individual Customer's of Ooredoo Mobile Prepaid Services who have spent a minimum of MVR400 (four hundred Maldivian Rufiyaas) on a transaction during the relevant Eligible Period shall be eligible for the Lucky Draw conducted during the Promotional Period 1 on the Lucky Draw Date as specified above.
7. Individual Customer's of Ooredoo Mobile Prepaid Services who have spent a minimum of MVR400 (four hundred Maldivian Rufiyaas) on a transaction each calendar month during the relevant Eligible

Period shall be eligible for the Lucky Draw conducted during the Promotional Period 2 on the Lucky Draw Date as specified above.

8. Any form of recharge or add-on purchase done in respect of the following connections shall not be considered as an Eligible Transaction and shall be excluded from the Promotion:
 - (i) Tourist Packs
 - (ii) Mobile Broadband packs/subscriptions
 - (iii) Connections registered to entities (COCP) and connections linked to business accounts
9. For the avoidance of doubt, a customer shall be counted only once for each lucky draw for which the customer is eligible, irrespective of the number of Eligible Transactions carried out during the relevant eligibility period. Accordingly, where a customer carries out more than 1 (one) Eligible Transaction of MVR 400 or more during a draw period in Period 1, or more than 1 (one) Eligible Transaction of MVR 400 or more in any month of a quarter during Period 2, such additional Eligible Transactions shall not result in additional entries into the relevant lucky draw.

Flow and Promotional Benefit

10. Ooredoo shall conduct 1 (One) lucky draw on each Lucky Draw Date during the Promotional Period, from among the Eligible Customers who have completed an Eligible Transaction during the among the Eligible Customers of the relevant Eligible Period of each Lucky Draw Date occurring during the Promotional Period.
11. Subject to clause 12 below, the Winners of the lucky draws shall receive 1 (one) return ticket to Dhaka, Bangladesh from Hulhule', Maldives ("Return Ticket") (each such prize hereinafter referred to as "**Prize**").
12. The winners of the lucky draws shall be required to collect the Prizes based on the schedule/dates as communicated by Ooredoo. If the Prizes are not collected as such, Ooredoo retains the right to cancel the win entirely without any liability to any party. Additionally, where a Prize involves travel or requires travel arrangements, the winner shall be required to notify Ooredoo of their intended travel dates by the deadline communicated by Ooredoo from time to time. Failure to provide the intended travel dates by the specified deadline may result in cancellation of the Prize and/or the winner's entitlement thereto, at Ooredoo's sole discretion, without any liability whatsoever to any party.
13. Unless otherwise stated herein or permitted by Ooredoo, the winners of the lucky draws shall not be allowed to transfer the Prizes to any other party or claim or be entitled for money or any alternate compensation or benefit in substitution of the Prizes or any part thereof.

General Terms

14. A Customer who is selected as a Winner in a Lucky Draw conducted under this Promotional shall not be eligible for any subsequent lucky draws conducted during the Promotional Period.
15. The lucky draw may be held directly by Ooredoo or by a third party appointed by Ooredoo, as determined by Ooredoo in its sole discretion.
16. In order to inform the winning customers of the lucky draw, Ooredoo is only required to call the mobile number (MSISDN) in respect of which the Eligible Transaction was carried out under this Promotion. Ooredoo will attempt to call the number on three different occasions. Where the customer is deemed unreachable or unresponsive at the sole discretion and opinion of Ooredoo, Ooredoo may decide to disregard the win entirely or award the win to another Eligible Customer as may be decided by Ooredoo in its sole and entire discretion.
17. Ooredoo reserves the right, in its sole discretion, to determine the manner, timing and method of announcing the winners of the Promotion. By accepting any Prize under this Promotion, each winning customer grants Ooredoo the irrevocable right to photograph, film, record and otherwise capture the winner's name, image, likeness and voice, and to use, reproduce, publish and distribute such content,

without additional compensation, for the purpose of announcing the Promotion winners and for Ooredoo's advertising, promotional and marketing activities in any media.

18. Ooredoo reserves the right, at any time and in its sole discretion, to substitute, modify, suspend or withdraw any Prize offered under this Promotion with another benefit of equivalent or greater value, or to cancel such Benefit altogether, without incurring any liability to any customer.
19. The terms and conditions of the Promotion as specified herein shall override any other communication received to a customer in relation to this Promotion, whether or not such is communicated to the customer by Ooredoo.
20. Ooredoo reserves the right, at any time and in its sole discretion, to amend, suspend, withdraw or terminate the Promotion, in whole or in part, without prior notice and without incurring any liability to any customer.
